Section 4. First aid measures

Description of necessary first aid measures

Personal precautions, protective equipment and emergency procedures

Methods and materials for containment and cleaning up

- Spill** : Stop leak if without risk. Move containers from spill area. Prevent entry into sewers, water courses, basements or confined areas. Section 7. Handling and storage

Precautions for safe handling
